By visiting the Packhunt website (<https://www.packhunt.io/>), the Packhunt platform (<https://app.packhunt.io/>), contacting Packhunt or using the Packhunt services (also named: Solutions), it is possible that certain personal data will be processed. Packhunt takes your privacy very seriously and shall handle your personal data with the utmost security and care. This Privacy and Cookie Statement offers information about the way Packhunt processes your personal and your rights concerning the processing of your personal data. ### 1. Responsibility for the processing of your personal data

## 2. Data we collect

Packhunt may collect the following data:

- Account and contact information: Name, address, e-mail, username, password.
- Financial information: Name or Company name, billing address, bank details, credit card details, payments and outstanding balance.
- Business information: Packhunt may collect (potential) customer information (information on our opportunity together in communication, call logs, notes and tasks and the opportunity type).
- Service data:
  - Account and contact information: Authorized Users using the Packhunt platform may invite people without a Packhunt account to their organization/workspace by providing an email address.
  - Files: Authorized Users using the Packhunt platform and services may upload files to use in Packhunt services (e.g. Geometry files, images, IFC files, etc.).
  - Input data: Authorized Users using the Packhunt platform and services may provide (model) input data (e.g. name, project name, building width, etc.).
  - Result data: Authorized Users using the Packhunt platform and services may generate and store data (e.g. calculation results).
  - Log data: The Packhunt platform infrastructure and servers automatically collect and record information in log files when any user accesses or uses the Packhunt Platform and services.
- Usage information
  - Metadata: Packhunt collects information that provides additional context about how you use the website, Packhunt platform and services. For example the users, features, content, links and third party services you interact with.
  - Device information: Packhunt may collect information about devices accessing the website, Packhunt platform and services. For example the type of device, operating system, device settings and crash data.
  - Location information: Packhunt may collect information about devices accessing the website, Packhunt platform and services to help approximate the device location.
- Third party services: Packhunt may collect information about third party services that Authorized Users integrate into Packhunt services.

## 5. Access to your personal data

## 6. Protection of your personal data

To protect personal data against unlawful processing, Packhunt uses technical and organizational security measures. To this end, Packhunt will protect personal data in a manner that can reasonably be expected.

## 7. Storage period

The moment the storage of the personal data is no longer necessary for the purpose for which it was collected, the personal data will be destroyed.

## 8. Transfer of personal data to third countries or international organizations

It may be necessary to transfer personal data to companies located outside the European Economic Area (“EEA”). If personal data is transferred outside the EEA, Packhunt will use the Privacy Shield or the EU Model Clauses to protect the personal data as much as possible.

## 9. Your rights

Under the GDPR you have the following rights:

- **The right to be informed and right of access (article 13,14 and 15 GDPR);**  
You may access your personal data and make any necessary changes in your account. If you would like to see which personal data Packhunt has obtained about you, you may exercise your right of access by submitting a request to Packhunt by contacting us through [privacy@packhunt.io](mailto:privacy@packhunt.io).
- **The right to rectification (article 16 GDPR);**  
If you wish to make changes in your personal information that you have seen as a result of a request for access and you are unable to make the changes yourself in your account, you may request that Packhunt make these changes for you. You may request that Packhunt modifies, corrects, supplements, erases or shields your information.
- **The right to erasure ('right to be forgotten') (article 17 GDPR);**  
You can request Packhunt to delete the personal data. It is possible to request this if:
  - The processing is no longer necessary for achieving the purpose;
  - The purpose of the processing is based on your consent and you withdraw this consent;
  - If you make well-founded objections to the processing;
  - If there is no legal basis for processing.
- **The right to restrict processing (article 18 GDPR);**  
In case you suspect that Packhunt uses your personal data unlawfully, you can restrict the processing.
- **The right to data portability (article 20 GDPR);**  
In case the processing of personal data is based on your consent or the necessity for the performance of the agreement, you have the right to obtain your personal data. Packhunt will provide this in a structured and standard format. In this manner you can transfer your data to another processor.
- **The right to object (article 21 GDPR);**  
In case you have any objection against the processing of the personal data, you have the right to object against the processing. You can send your request to exercise the rights to [privacy@packhunt.io](mailto:privacy@packhunt.io). Packhunt will respond within one week. In case of any legally complicated requests, Packhunt is entitled to extend this period of time with two months and will inform you about this together with an estimation of time in which Packhunt can comply with the request. In case of complaints regarding unlawful processing of personal data, you have the right to contact the national data protection authority. In The Netherlands, this is the Autoriteit Persoonsgegevens.

## 10. Cookies

The moment you visit Packhunt's website and/or the Packhunt platform or services, it collects certain information in an automated way by using cookies. Cookies are small text files on your computer (or other devices with internet access) that are saved on the moment you visit a website or platform. When a cookie is necessary to offer the service, explicit consent must be asked to accept the cookie on your device. Cookies permit a website or platform to recognize your device. Cookies can have several objectives: to consider the preferences of the user by for example language preferences, remember passwords, login data, collect statistical data, alter the content etc.

Packhunt use cookies for the following objectives:

- To alter the mobile site in the version suited for the mobile device
- Identify the user and track the user's session
- Indication how the site is rendered
- Security

There are different kind of cookies:

### A. First-Party Cookies

The cookies that have been set on the Packhunt website and/or the Packhunt Platform.

### B. Third-Party Cookies

The cookies that have been set on the Packhunt website and/or the Packhunt Platform by another domain than the Packhunt website and/or the Packhunt Platform (for example Google Analytics-cookies).

### C. Session Cookies

These cookies are on the Packhunt website and/or the Packhunt Platform to link actions during a specific browser session to a user. These cookies will be deleted when a user closes the browser.

### D. Constant Cookies

These cookies stay during a certain period on the device of the user.

Packhunt uses the following cookies on its website and/or the Packhunt Platform:

- **Strictly necessary cookies**

Cookies that let users browse through the website. This is necessary for security reasons.

Packhunt uses:

- JWT

- **Functionality cookies**

Packhunt doesn't use functionality cookies to make the website able to remember user choices to offer personal functionalities. These cookies cannot follow your browser activity on other websites and do not collect information that can be used for advertisement objectives.

- **Third party cookies**

Some cookies are from other third parties, like Google Analytics. These companies use the cookies to collect information about your interaction with Packhunt's website, like the pages you visit, links you click on and the visitor time on our website.

- Google Analytics
- MS Clarity

In case you wish that the cookies of Packhunt's website are not placed on your device, you can select this option by your first visit to Packhunt's website. When you have already accepted the cookies, the cookie notification disappears. In that case you need to delete the cookies.

In case you wish to block or delete cookies, or alter your cookie settings, you can do this by changing the settings of your browser [Internet browser: Options >> Preferences]. When you use several devices to visit the website, you need to alter the settings of every device to your cookie preferences.

Take into account that when you block certain cookies, a possible consequence is that certain parts of the website and/or graphic elements are not accessible or not usable.
