3. Access to your personal data

White Lioness will not share your personal data with third parties, unless this is necessary for the services (for example hosting of the website) or if White Lioness is obliged to do so under applicable law and/or regulations. In the event of use by third parties, White Lioness will, in accordance with the General Data Protection Regulation ("GDPR") ensure appropriate data processing agreements (if required), whereby the security of personal data is guaranteed by the processor.

4. Protection of your personal data

To protect personal data against unlawful processing, White Lioness uses technical and organizational security measures. To this end, White Lioness will protect personal data in a manner that can reasonably be expected.

5. Storage period

The moment the storage of the personal data is no longer necessary for the purpose for which it was collected, the personal data will be destroyed.

6. Transfer of personal data to third countries or international organizations

It may be necessary to transfer personal data to companies located outside the European Economic Area ("EEA"). If personal data is transferred outside the EEA, White Lioness will use the Privacy Shield or the EU Model Clauses to protect the personal data as much as possible

7. Your rights

Under the GDPR you have the following rights:

- **The right to be informed and right of access (article 13,14 and 15 GDPR);**
You may access your personal data and make any necessary changes in your account. If you would like to see which personal data White Lioness has obtained about you, you may exercise your right of access by submitting a request to White Lioness by contacting us through privacy@white-lioness.com.
- **The right to rectification (article 16 GDPR);**
If you wish to make changes in your personal information that you have seen as a result of a request for access and you are unable to make the changes yourself in your account, you may request that White Lioness make these changes for you. You may request that White Lioness modifies, corrects, supplements, erases or shields your information.
- **The right to erasure ('right to be forgotten') (article 17 GDPR);**
You can request White Lioness to delete the personal data. It is possible to request this if:
 - The processing is no longer necessary for achieving the purpose;
 - The purpose of the processing is based on your consent and you withdraw this consent;
 - If you make well-founded objections to the processing;
 - If there is no legal basis for processing.

- **The right to restrict processing (article 18 GDPR);**
In case you suspect that White Lioness uses your personal data unlawfully, you can restrict the processing.
- **The right to data portability (article 20 GDPR);**
In case the processing of personal data is based on your consent or the necessity for the performance of the agreement, you have the right to obtain your personal data. White Lioness will provide this in a structured and standard format. In this manner you can transfer your data to another processor.
- **The right to object (article 21 GDPR);**
In case you have any objection against the processing of the personal data, you have the right to object against the processing. White Lioness will respond within one week. In case of any legally complicated requests, White Lioness is entitled to extend this period of time with two months and will inform you about this together with an estimation of time in which White Lioness can comply with the request. In case of complaints regarding unlawful processing of personal data, you have the right to contact the national data protection authority. In The Netherlands, this is the Autoriteit Persoonsgegevens.

8. Use of personal data

The moment you visit White Lioness' website and/or the Packhunt.io platform it collects certain information in an automated way by using cookies. Cookies are small text files on your computer (or other devices with internet access) that are saved on the moment you visit a website. When a cookie is necessary to offer the service, explicit consent must be asked to accept the cookie on your device. Cookies permit a website to recognize your device. Cookies can have several objectives: to consider the preferences of the user by for example language preferences, remember passwords, inlog data, collect statistical data, alter the content etc.

White Lioness use cookies for the following objectives:

- To alter the mobile site in the version suited for the mobile device
- Identify the user and track the user's session
- Indication how the site is rendered
- Security

There are different kind of cookies:

B. Third-Party Cookies

C. Session Cookies

These cookies are on the White Lioness website and/or the Packhunt.io platform to link actions during a specific browser session to a user. These cookies will be deleted when a user closes the browser.

D. Constant Cookies

These cookies stay during a certain period on the device of the user.

- svSession

Some cookies are from other third parties, like Google Analytics. These companies use the cookies to collect information about your interaction with White Lioness' website, like the pages you visit, links you click on and the visitor time on our website.
